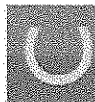

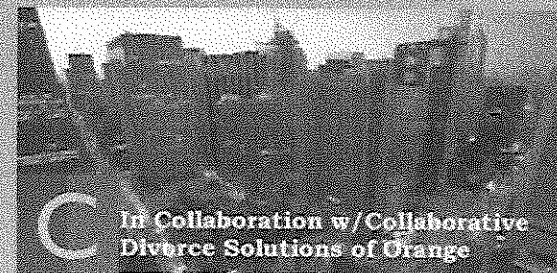

The Trainers

Vicki Carpel Miller, BSN, MS, LMFT is a licensed Marriage and Family Therapist in private practice for over 20 years, specializing in the treatment of Vicarious Trauma, the practice of Collaborative Divorce, the treatment of blended families and divorce related issues, and the Rapid Advance Process. Vicki is a past Board member (2004-2006) of the International Academy of Collaborative Professionals (IACP) and served on the Executive Board as Secretary. She is a past member of the IACP Standards Committee, the Advisory Council on Collaborative Training and Practice of the IACP, the Core Skills Institute Committee, and several Forum Planning Committees. She, along with colleagues from the Collaborative Professionals of Arizona and principals of Collaborative Divorce Team Trainings authored the Protocols for Collaborative Divorce Full Team Interdisciplinary Practice.

George B. Richardson, JD, is a pioneer in Collaborative Practice, having handled scores of collaborative matters, and is a founder and former President of Collaborative Practice Silicon Valley, one of the oldest collaborative law organizations in North America. He was among the first recipients of the *Eureka Award*, given by Collaborative Practice California to recognize those who "have made significant contributions and demonstrated an



abiding dedication to establishing and sustaining Collaborative Practice in California". He is currently on the Board of Directors and President of CP Cal. As a charter member of the International Academy of Collaborative Professionals and as a former co-chair of the IACP Standards Committee, he was a principle drafter of IACP's standards with respect to Collaborative ethics, practitioners, trainers, and trainings. Since 1999, he, together with others, has trained Collaborative practitioners in the United States, Canada, and Australia through fundamental and advanced courses in Collaborative Practice.

Nancy Ross, LCSW, BCD is a co-founder of the Collaborative Divorce Interdisciplinary concept and principal of Bauer, Shepherd & Ross & Associates, a group psychotherapy practice in Cupertino, California. As a clinician for over 30 years, Nancy has specialized in couples and family therapy. Currently, over 80% of her practice is dedicated to collaborative work. She is a Certified Interpersonal Communications Trainer, training work teams, Interdisciplinary Collaborative Practice teams and practice groups in effective teamwork. She conducts trainings with Collaborative Practice Silicon Valley Trainers. She has taught Collaborative Practice at Santa Clara University School of Law. A co-author of *Divorce: A Problem to be Solved, Not a Battle to Be Fought* and author of numerous articles on Collaborative Divorce, she teaches and trains with Collaborative Divorce Team Trainings and present the concepts nationally and internationally.

Tamara Rounds, MSW, LCSW is a licensed clinical social worker and family therapist. Tamara divides her professional time between Arizona State University where she is a Lecturer teaching advanced clinical coursework and her mental health private practice where she specializes in child, adult, family and adolescent issues.
